APPROVAL OF MINUTES from March 19, 2019

Motion presented, granted with two changes – spelling of Phyliss Royster's name (Phyliss, rather than Phyllis) and that Linda Gilley was in attendance at the last meeting. Minutes were approved.

PASTOR'S REPORT (Fred)

Pastor Fred is working on a list of goals to strive for during his last year. Staff has done a survey regarding job descriptions, job duties, spheres of responsibility, and will be reporting that out to the Long Range Planning Committee.

Fred plans to remain at FCC through April 19th of 2020. Board will be voting on this timeline.

TREASURER'S REPORT (Chris)

- We are tracking below budget on the income side, especially for the plate budget. We are about half of what we were this time last year. We are about 6% lower than we would like to be at this point in the year, so we need to be mindful as we move forward in the year. Board discussed possible ways to communicate this to the congregation to encourage plate donations.
- Expenses are generally tracking to a little higher, but should even out. Snow removal was high this year and we are still waiting for reimbursements for memorial services.
- We are significantly ahead of the budget for weddings, and sharing fees for the church building.

 - FCC Preschool Dallas Collins is now an interim director of the preschool
 - Jamie Ford is now FCC Director of Church Operations; her administrative position will be filled on an interim basis as needed while staff is evaluating if that position is necessary
 - Currently we have 4 candidates for Pastoral Care

Action Item 1- Pastor Fred's resignation

Board voted on Pastor Fred's resignation as FCC Senior Pastor on April 19, 2020.
 Fred submitted a letter of resignation with that date stipulated. A motion was made, and a voice vote taken. Motion was approved.

Action Item 2 - Director of Church Operations position

- Board voted to endorse Jamie Ford as the new Director of Church Operations. Motion was made and a voice vote was taken. Motion was approved.
- Nominating Update (Theresa, Betsy)
 - Action Item 3 2020-2022 Board and Committee Slate
 - Board reviewed and discussed the 2020-2022 Board and Committee Slate.
 Motion to approve was made, voice vote was taken. Motion was approved. The slate will be published in advance of the June 23rd meeting, and then the Congregation will vote on the slate.

Pastor Search Committee update

- This task has been given to the Nominating Committee to put it together. They
 have a number of candidates who were submitted by the Congregation, and are
 getting together next week to review and propose a slate. Goal will be to get a
 slate together prior to the June 23rd Governing Board meeting.
- o Long-Range Vision Committee, Recommendation (Dana, Betsy)
 - Rationale for Proposed FCC Board and Committee Changes
 - Combine Board of Lay Ministries & Board of Congregational Life into one Board of Congregational Connections
 - Change Board of Outreach Ministries to "Board of Faith in Action" to bring more focus to hands on mission opportunities, social justice, environmental issues, etc.
 - Change Elder requirement to 2 years FCC membership from 3 years
 - Make Governing Board Focus Elder an as needed, optional position
 - Eliminate 2nd Personnel representative on Governing Board
 - Anywhere the language said 3-year terms, we changed to 1, 2, or 3-year terms to provide more flexibility
 - Board discussed the proposed changes and rationale for the changes.
 - Action Item 4 FCC Constitution and Bylaws revisions
 - Proposed changes consist of the following:
 - By-laws Article 3, section I & J (and renumbered items K & L):
- A. Any board or committee member attending in the absence of their elected chair may not vote nor participate in executive sessions of the Board. Any individual attending at the request of an elected Elder, such as a Board or Committee member, may not vote nor participate in executive sessions of the Board.
- B. The board may, it its discretion, invite board, committee, or other members of the congregation to participate in an executive session of the board as a means to gather appropriate information related to a predefined agenda item. These individuals may not vote and shall be dismissed from executive session prior to any such vote taking place.

The Board of Congregational Connections shall consist of up to 12, but no fewer than 8 members. 10-12 members. The Board shall be responsible for welcoming and inviting visitors to FCC (including recruitment, training and scheduling of FCC Hosts), New Member Information Sessions, shepherding and connecting newer members into the active life of the congregation, reaching out to inactive members, and providing fellowship opportunities to develop a sense of Christian Community.

The Board of Faith in Action (new language in blue)

The composition and responsibilities of the Board of Faith in Action shall be as specified in the Constitution or elsewhere in these by-laws. Faith in Action shall evaluate opportunities for Christian outreach with organizations or programs through and beyond Flossmoor Community Church; prepare recommendations to and obtain concurrence from the Governing Board for mission grants; provide opportunities for conversations related to outreach including, but not limited to social justice and environmental issues; provide regular events for hands on mission; and communicate with the Finance Committee, the congregation, and other Boards and Committees within the Church.

- Motion was made to approve the proposed changes to the FCC Bylaws as discussed. Motion was approved.
- Motion was made to approve the proposed changes to the FCC Constitution as discussed. Motion was approved.

Properties Committee

August 2019

Highlights

- Exterior painting completed in July.
- Sanctuary AC repair. The coil for the A/C unit in the Sanctuary was damaged during the Polar Vortex and needed to be replaced. We are working with Arctic, our HVAC contractor to improve our cooling capabilities in the Sanctuary.
- Front Door will be repaired and painted. Hoping to have the work completed before New Season Sunday, 9/8.
- Sign replacement signs were replaced on Flossmoor Road, near Travers and outside of the Preschool. The sign post outside the preschool also needed to be completely rebuilt.
 - We are hoping to update and replace the signs on Travers Rd and Hutchison in the next month.
- We are getting estimates for building cleaning. While we are happy with our current cleaning person, we need to plan for the future and budgeting needs.
- Contacting Roofing companies for replacement of flat roof over the music wing (Travers).
- Working with Foundation to update our 2019 Special Projects and planning for 2020.

- Pest Control we are in the process of hiring pest control for both 2218 and 847 Hutchison. We will then need to have extensive cleaning and repair done on the Organ chambers, due to mouse infestation.
- Properties is reviewing our current lawn maintenance agreements and getting estimates to consolidate all lawn maintenance needs.

Hopes

- Remove dead tree on Community House lawn.
- Repair asphalt in CH lot due to village work on water line in January 2019.
- Repair/replace plaster in CH.
- Replace three rotting wood exterior doors with aluminum.
- Replace three glass inserts in Youth Crossings Door.
- Plan for 2020 Stained Glass repairs.
- Plan for additional Reserve Study Updates.
