# TREASURER'S REPORT (Bob)

Plate and pledge revenues were below budget and below year over year, but not a concern at this time. In pledges, we are about \$20,000 below year over year, but we had very strong December.

- Audit Finance committee is committed to performing an audit this year, will start and complete it in March, then provide summary to Governing Board at April meeting.
- Current FCC bylaws state that a formal audit is to be conducted every 5 years. Formal audit includes financial records, processes and procedures, with a report to the Governing Board and a summary of follow-up actions/next steps
- Went through FCC audit reports from '98-'99, as well as other best practices of other churches' audit practices
- Dan Lavin will chair this year's audit committee; he has performed several audits at other churches previously; Nancy Rubin will work with Dan and they will serve as the audit committee; will work closely with Judy Jensen
- Are submitting recommended revisions to the audit process to the Governing Board to reflect changes that account for our current bylaws
- Are asking for approval of the recommended bylaw revisions and confirmation of the Finance Committee to move forward with the audit in March
- Governing Board members took a voice vote and was approved

# PASTOR'S REPORT (Fred)

- Have had 2 funerals and 2 baptisms in January
- Went to a conference on transitional ministry transitions are always happening no matter what
- This conference impacted Fred in looking ahead to our Lenten Series theme is Holy Transitions; to focus on how the biblical record shows that God is always moving us from one thing to another
- Feed feels like the morale of the church is in a good place

## **Stewardship** (Rick)

Our pledge base is now \$560,000 so the gap is now about \$67,000. We had a few pledges come in; sent letter out this week as reminders. Four gifts have come in so far in response to the 2020 Challenge

**Pastor Search Committee** (Anna in lieu of Chris Dolan)

Three final candidates were interviewed in person; 1 stood out in particular and that candidate has been invited back for a second visit in March where she will have the opportunity to meet with members of the Governing Board and the Personnel Committee. She will be presented with an offer; we will offer a call; if accepted, the congregation will be notified. Ultimately May  $2^{nd}$  and  $3^{rd}$  would be the call weekend when the Congregation would have the opportunity to vote.

### Personnel

*Update re Praise Director Search* (Sharon)

Search is ongoing driven by Katie Van Heel; the job is still posted on many job sites and is still receiving applications but have not yet found right fit. Katie will be circling back to earlier candidates to see if they may be interested now that we have a pianist in place. She will also continue to monitor the applicants and is still hoping to hire in time for August.

Difficult to find comparable salary information because the set up varies so much from church to church.
